SUSI GRANT SCHEME FOR POSTGRADUATE STUDENTS

The Student Grant Scheme is the main financial support scheme for students studying in Ireland and abroad. It is also known as the SUSI grant because the Student Universal Support Ireland (SUSI) is the awarding authority for the Student Grant Scheme. SUSI offers funding to eligible students in approved full-time courses at PLC, undergraduate and postgraduate levels in Ireland and in some cases, to students studying in the UK or EU.

Those applying for a postgraduate course in ATU may be eligible for financial support. Depending on the level of a student's reckonable income, a postgraduate fee contribution of \notin 4,000 or a postgraduate fee grant, up to a maximum of \notin 6,270, towards the cost of fees plus a maintenance grant is available to postgraduate students pursuing an approved course.

- Postgraduate students who are eligible for the postgraduate fee contribution of €4,000 are not eligible to receive the maintenance grant.
- Maintenance grants are paid at adjacent and non-adjacent rates. The adjacent rate is paid when a student's college is less than 30km from their normal residence. The non-adjacent rate is paid when a student's college is 30km or more from their normal residence.

SUSI FUNDED PART-TIME UNDERGRADUATE STUDENTS

The Irish Government has approved a part-time fee scheme for SUSI funding. For programmes to be eligible for this scheme they must lead to an undergraduate major award, such as a Higher Certificate, Ordinary Degree, or Honours Degree. You will need to complete between 30 and 50 credits each academic year, with any remaining credits arranged in your final year. Classes can be attended in-person or through a hybrid format that includes some in-person sessions beyond just registration, enrolment, or exams.

Grants

TAX RELIEF

As ATU is listed by the Irish Revenue as an 'Approved Institution', students are eligible to claim tax relief at the standard rate for tuition fees. To determine your own eligibility and if the course you have applied for qualifies for a tax refund, please visit **revenue.ie** and see the "Personal tax credits, reliefs and exemptions" section for more information.

BACK TO EDUCATION ALLOWANCE (BTEA)

If you are unemployed, parenting alone or have a disability and are getting certain payments from the Department of Social Protection, you may take part in a second or third level education course and receive a Back to Education Allowance (BTEA).

It is important to note that you cannot get the BTEA and the maintenance component of a student grant together.

In order to get the BTEA when going to college, you must accept your place on a full-time course, and then notify the Department of Social Protection by filling out the BTEA application form. Further information can be found at **Citizens Information**.


OTHER FINANCIAL ASSISTANCE

There are two funds available to help students who find themselves in financial difficulty:

- The Student Assistance Fund (SAF) is a Government fund intended to provide financial support to disadvantaged full or part-time students who require additional financial support to enable them to fully benefit from their third-level studies. This funding can be put towards the costs of accommodation, transport, books and class materials, food and utilities, medical expenses and childcare but cannot be used to cover college fees.
- The Student Support Fund (SSF) is a limited emergency fund available to students who experience unexpected financial difficulties during their time at university. Such support is often offered in the form of a short-term loan.

Scholarships

At ATU, we support the pursuit of lifelong learning. Scholarships allow our students and ATU Alumni to achieve excellence in their field while also giving them an opportunity to build valuable relationships and enhance their career prospects.

Alumni Scholarship

ATU Alumni comprises of over 100,000 graduates. As part of the suite of benefits for members of the ATU Alumni Network, the ATU Alumni Office offers a reduction in academic fees for alumni who pursue a Masters programme at ATU.

The reduction in fees is available to those who:

- Have completed a Level 8 undergraduate degree at any ATU campus (including legacy Institutions).
- Register as a student on a Level 9 Masters award (min. 90 credits)
- Register with the ATU Alumni network.

The discount can be applied to both full-time and part-time Masters programmes, and includes all delivery formats, on-campus, online, or blended. The scheme will be open to students who commence their Masters with ATU in 2025/26. Some course exclusions may apply.

Sports Scholarship

The ATU Sports Scholarship programme provides both financial and non-financial benefits to talented student athletes. The programme is open to new full-time undergraduate and postgraduate students attending any of the 9 ATU campuses.

Financial benefits are awarded at Gold (€3,000 per annum), Silver (€1,500 per annum) and Bronze (€500 per annum) level. Non-financial benefits include reduced gym fees, free sports gear, national and international competition support.

ATU/Gaelic Players Association (GPA) Postgraduate Sports Scholarship

This ATU/GPA (Gaelic Players Association) partnership allows for up to 12 fully funded, postgraduate places to male and female members of the GPA who wish to study at ATU. The scholarships will benefit current and former inter-county players who are accepted onto any full-time or part-time Masters programme within ATU.

Applicants can apply for the scholarship once they have secured their place on their programme of choice. 50% of the course cost will be covered by ATU with the remaining 50% covered by the GPA.

Galway Wind Park Scholarship

The Galway Wind Park Scholarship Programme aims to maximise value for local communities by funding third-level education opportunities for people living within 15 kilometres of Galway Wind Park in Connemara.

Successful scholarship recipients will receive 50% of the Student Contribution Fee, to be paid over the duration of their course, to a maximum of three years for undergraduates and one year full-time or two years part-time for postgraduate courses.

Funding

The Department of Further and Higher Education, Research, Innovation and Science (DFHERIS) facilitates skills development by managing a number of national initiatives, such as Springboard+, Skillnet Ireland and the Human Capital Initiative (HCI). These initiatives provide free and subsidised upskilling and reskilling opportunities in higher education in areas of identified skills need.

SPRINGBOARD+ & HCI FUNDING

Each year, the Higher Education Authority (HEA) approves courses for Springboard+ and Human Capital Initiative (HCI) funding. Places are limited and are granted in areas where there are known skills shortages in the domestic economy.

Students interested in studying on a Springboard+ or HCl approved courses must apply to Springboard+ directly and must meet eligibility criteria.

If you are employed and are completing a Level 9 course that is supported by Springboard+, it is 90% funded and you are required to pay the remaining 10% tuition fee. If you are unemployed, Springboard+ will cover 100% of the course fees.

FEE PAYMENT OPTIONS

Self-Funded

To help make payments more manageable for students who are self-funding, ATU has a variety of payment options that include payment per semester, in-full or by instalment.

Self-funded students can choose from one of the following payment plans.

Payment Plan 1: September & January Intake: Pay 100% of tuition fees at registration.

Payment Plan 2:

September Intake (only): Pay 50% of tuition fees by October 31st and 50% by January 31st.

Payment Plan 3:

September Intake: Pay 20% of your tuition fees at registration and then pay 10% per month for 8 months.

January Intake Pay 20% of your tuition fees at registration and then pay 20% per month for 4 months.

Students on short courses with fees of €500 and under must pay 100% of their fees at registration or 2 instalments of 50% fees for that course. First payment due by 31st October and second payment due by 31st January.

For stand-alone modules which run over one Semester only, the module fee must be paid in full by the end of the Semester in which the module is undertaken.
