Introduction

In 2019 ATU Galway Mayo (formally GMIT) signed an MOU with Niagara College in Canada, whereby students from Niagara College on completion of their 2-year Diploma in Early Childhood Education and Care, could apply to ATU Mayo to enter year 3 to complete the BA(Hons) in Early Childhood Education and Care. At this time, it was agreed the faculties would arrange mobility trips for students from Niagara College and ATU Mayo.

In 2022 a delegation of Academic Staff and students from Niagara College began the first of the mobility trips through the Be World Ready Funding in Canada. This weeklong study trip to ATU Mayo, allowed students to partake in activities on and off Campus. A return trip was organised by ATU Galway Mayo and February 2023 saw a delegation of Academic staff and students attend Niagara College as an educational and cultural experience supported through the Galway Mayo International Office.

During the February 2023 trip academic staff led by Dr Justin Kerr met with Dean Carol Philips and her team to discuss ongoing collaboration. Under the MOU between Institutes of Technology Ireland and Colleges of Ontario "IOTI and Colleges Ontario's will, subject to the laws, rules. Regulations and national policies from time to time in force, governing the subject matter in their respective countries and/or province, take the necessary steps to encourage and promote the co-operation in the following areas including faculty, student and administrative exchanges and distance education". (MOU, IoTI & Colleges Ontario, 2011). It was agreed ATU Galway Mayo would write a 5-credit module for students from Niagara college to take as an elective module from their programme. Niagara College chose 5 programmes which the elective module would be offered.

The module is Level 6 and will be blended delivery. Students will complete some of the module online in Niagara University, have one week of intensive learning onsite in Mayo and then complete the module online when they return to Niagara. The module is not Early Childhood Education and Care specific and so it is hoped that in the future, the module will be taught on different programmes in Mayo following the appropriate quality assurance process to amend programme schedules.

Rationale for Module

The aim of the module is to provide students with an understanding of the holistic benefits that physical activity, recreation, learning and play can have a across a range of environments and spaces. Students will be introduced to various pedagogies and leadership theories that will enable learners to become educators and leaders in the promotion of suitable environments to ensure a person's health and well-being flourish. The module is both inter-cultural as well as generational in that it focuses on the shared spaces, nationally and internationally, between early childhood, adolescent, and adults as they come together to share and appreciate the role of meaningful 'relationships' in education and care.
